Subject - Fixing of minimum age of a child to be admitted in the School in the academic year 2022-23.

In pursuance of the Government Resolution cited at reference No. 1 above is hereby directed that minimum age of a child to be admitted in the school in the academic year 2022-23 is fixed as under

As per Government Resolution dated 18/09/2020, regarding fixation of minimum age of a child to be admitted in the school in the academic year 2022-23 is and will be effective from the date 31st December.

Therefore, the children born in the months of October, November and December are facing problems in admission in the academic year 2022-23. In view of the students should not suffer from educational loss due to effective date, the student shall have completed the age as on 31/12/2022, for the admission in the academic year 2022-23 as under.

1	Play Group / Nursery	1 October 2018 to 31 December 2019	3
2	Junior K. G.	1 October 2017 to 31 December 2018	4
3	Senior K. G.	1 October 2016 to 31 December 2017	5
4	Standard I	1 October 2015 to 31 December 2016	6

The age for admission in pre-primary education is flexible. To what period of years the pre-primary education is to be taken, at what age the admission is to be sought, in which standard admission is to be sought all these points are depending on the desire of the guardians. The schools are not expected to reject the admission in the pre-primary classes on the reason of the higher or lesser age.

This Government Resolution dated 18/09/2020 is mainly applicable for the admission in the first standard. The Government by this Government Resolution has fixed the age limit.

The maximum age limit is not fixed. There is no objection to be flexible in maximum age limit.

After fixing age limit of 25% RTE admissions, the same will be communicated in due course. Therefore, all the schools be informed in connection with the age limit at your level, therefore, the office may not receive any complaint regarding age limit of admissions.
